Nationally, only six percent of Medicare-certified home health agencies achieve this level of excellence. In Washington, only two home health agencies earned five stars. For Wesley Home Health, the continuity of care between the physician, hospital and home is a big part of their success.

"Medications prescribed from a hospital stay may differ from a prior dose, so our staff have clients gather all their medications for a review," said Director of Clinical Services Jolene Rhodes. "This allows us to assure that new and existing medications throughout the home are reconciled to help prevent incorrect dosages, interactions or re-hospitalizations. Doing this prevents mixups and allows for client education, preventing complications upon returning home."

Wesley Des Moines Health Center earned an overall five-star rating based on a state review of health inspection, fire safety, staffing and care quality.

"Our five stars signal superior care and personal service," said Des Moines Health Center Director of Nursing Noel Donato. "The ratings help families know they are making the right decision when they choose Wesley to care for their loved one."

Wesley Lea Hill Rehabilitation & Care Center also earned a five-star quality measures rating. Director of Nursing Services Alhaji Suwaneh credits the center's staff for its success.

"All of our staff do whatever it takes to give residents the best experience," said Ali. "Their dedication really comes through."

Wesley launches novel program: Catered Living

Catered Living is a home care program offered in The Commons neighborhoods at Wesley Lea Hill and Wesley Bradley Park.

Similar to traditional assisted living, Catered Living provides scheduled and unscheduled services with certified nursing assistants and registered nurse oversight 24 hours a day, 7 days a week.

What makes Catered Living different from other programs is the care package point system, which assigns a point value to each service based on the

time and level of involvement required to perform that service. A care coordinator from Home Care by Wesley, the personal care service division of Wesley Health & Home Care, reviews services and levels with each resident to determine the best package to meet their needs. The individualized care package is designed so program participants receive and pay only for the services they need to remain as independent as possible for as long as possible. For those in transition, this flexible program allows residents to increase or decrease support as needed.

Wesley and City of Des Moines create public-private partnership

When the director and manager of the Des Moines/ Normandy Park Senior Activity Center retired, the City of Des Moines decided to forgo a recruitment process to fill those positions and chose to work with Wesley Des Moines.

The two-year pilot agreement enables Wesley to plan, implement, manage and evaluate senior services programs, including recreation, social, continuing education, health, human services and nutrition programs. The center's Senior Engagement Program Manager, Kathy Burrows, was hired and is paid for by Wesley, but the city reimburses Wesley. Through Kathy, Wesley is also responsible for creating and managing the center's budget; evaluating and making repair recommendations for the facility; obtaining sources of funding and grants; and coordinating personnel, volunteers and special events.

Wesley President / CEO Kevin Anderson, Wesley Des Moines Executive Director Alex Candalla

and the city manager have oversight of the pilot project. The agreement between the city and Wesley can be reviewed, re-evaluated or terminated by either party after 90 days or extended for an additional two years.



Support during a time of need

When Wesley receives awards, thanks must always go to the hardworking employees who dedicate so much to our goal of excellence. Wesley is grateful to be able to support staff when needed.

Wesley Community Foundation distributed 23 educational and emergency grants to staff that desired to increase their skills or needed help during a crisis. When a series of ill-timed events - major surgery, eviction notice and car troubles - occurred to a single parent, the Foundation delivered a check directly to the apartment complex to keep the family in their home. Grants were also provided to staff for airfare to visit a mother in hospice care and attend a funeral.

The Foundation sponsored three Leadership Academy trainees for a year-long leadership development program. The course is designed to enhance the leadership skills and core competencies of nonprofit leaders within the LeadingAge membership.

Subsidizing Care

Wesley provides a significant contribution to the greater community, and our efforts are representative of our mission to serve others.

The Bishop McConnell Scholarship Program provided nearly \$155,932 in subsidies to 16 qualifying residents, allowing them to live at Wesley and receive care as needed.

Wesley Community Foundation raised funds for the Des Moines and Lea Hill Circle of Concern endowments to help support qualifying Wesley residents who have exhausted their resources through no fault of their own. Residents, family and friends also financially supported this program. The Circle of Concern program provided \$216,735 in subsidies.

When Medicaid reimbursements fall short for long-term care residents of Wesley Des Moines Health Center, Wesley Lea Hill Rehabilitation & Care Center and Wesley Health & Home Care, Wesley absorbed this shortfall of over \$3 million.

Our mission guides us to give back to the communities where we live and work, and Wesley's community programs help improve the quality of life of those we serve.

Spreading the love by giving back

Wesley welcomed old and new friends to our communities, and supported other non-profit organizations in the South Sound.

Our Living the Mission team held food and warm clothes drives for the needy and raised funds for the Walk to End Alzheimer's. The walk is a Wesley favorite event because it brings residents, staff and their families together for a worthy cause.

Keeping our wisest and youngest connected is a great way to convey values and traditions from one generation to another. Visits from the children at Busy Bee Preschool in Auburn are always welcomed by Lea Hill residents.

Intergenerational programs, such as our Highline Montessori at Wesley preschool, are great ways to share technology, promote independence, encourage residents to volunteer and build a sense of individuality while encouraging tolerance. These programs also help reduce the isolation older adults sometimes experience and help fill the void for children who may not have grandparents available to them.

Highline College students participated in the Students-in-Residence program, which provided

affordable housing at Wesley Des Moines. The students volunteered with residents, providing social connectivity and cognitive stimulation for residents.

World Relief refugees were also a source of social interaction for residents. These folks were able to live at Wesley Des Moines at a reduced rental fee as they improved their English, often with the help of residents, took classes to become employable and became independent.

Residents volunteered at the preschool, but they volunteered for other organizations, too. The hours of their contribution to the greater community is valued at nearly \$14,000.

Wesley Lea Hill hosted several Auburn Foster Parent First Aid/CPR and Blood Borne Pathogens classes. To become a licensed foster parent in Washington, applicants must complete this class.

The Lea Hill campus also held a blood drive with Cascade Regional Blood Services. The blood will go to people who need it in the Pierce and South King county areas.



Popular Wesley U, extended learning courses that began at Wesley Des Moines, expanded to Wesley Lea Hill and Wesley Bradley Park in 2018. Highline College, King County Library, Des Moines/Normandy Park Activity Center, Humanities Washington and Pierce College helped provide content. Classes continue to be free to residents and older adults within the greater community. Wesley Community Foundation helps fund the program.

Providing meeting space for fellow non-profits, Wesley welcomed our long-time friends at the United Methodist Church, the Sunuppers chapter of Toastmasters International®, the Home Care Association of Washington, the Daughters of the American Revolution® and LeadingAge® Washington.

Other long-time friends of Wesley included the Cub Scouts, the Genealogical Society, the Rainbow Girls Foundation, the Children's Therapy Center and the beeping Easter Egg Hunt for blind children.

For the first time, Wesley supported the mission of Seattle's Union Gospel Mission: KentHOPE Day Center for Women and Children. Their
